Back in March of 2019, My doctor, Eric Tomomi Shigeno was working at the Borrego Health Clinic on 6th and Est in San Bernardino. I had planned to finally bring up a subject that had been [disturbing my sleep] bothering me ever since I arrived back in my hometown in July of 2017. Ever since I can remember back to growing up, I have never seen such an effort by people to not become an agency of corroborative conversation. Never have I ever seen such a resistance to subjects I am needing to discuss. 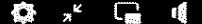
